- 2. If AICTE affiliation is obtained for B.M.S. degree then it will make us to follow the guidelines of AICTE which is quite difficult for traditional college as us.
- In the notification issued by UGC dated 3rd April 2023, under the clause 10.4 An Autonomous college may rename an existing course as per the UGC Notification on specification of degrees 2014.
- 4. According to Uniform Statute number 3 of 19 notified by Government of Maharashtra dated 14th January 2019 under clause 3 (1)(ii) about terms and conditions of autonomous colleges An Autonomous college has a right to formulate new courses or programs in consonance with the nomenclature specified by the UGC specification of degree 2014 notification no F.S. /2013 (CPP II) published in Gazette of India dated 5th July 2014.
- 5. As discussed in Board of Studies meeting in Management Studies dated 1 March 2024 agenda number 2, the proposal was presented before the BOS and after having detailed






