Eligibility: A candidate for being eligible for admission to the Master of Commerce (Advanced Accountancy) Semester I, shall have passed the Examination for the degree of Bachelor of Commerce of University of Mumbai (Three years integrated programme) or the degree of B.Com. (Old programme) of University of Mumbai or Bachelor of Commerce (Accounting and Finance) or B.Com. (Banking and Insurance) or B.M.S. degree Examination or an Examination of any other University recognized as equivalent thereto.

Availability of Admission form

i The online forms for admission will be available at www.ckthakurcollege.net between 4th November 2020 to 10th November 2020.

Fill in the correct information and upload the supporting documents as mentioned in the form.

Last date for filling up the form is 10th November 2020 up to 5 p.m.

University Pre-Registration Form

i University Pre-Registration Form is the mandatory document required for confirmation of admission. Visit university website www.mum.digitaluniversity.ac for the purpose. In case the University has not commenced the Pre-Registration process then students should undertake to submit the pre-registration form to the college office immediately after the Pre-Registration process begins, without which the admission will not be confirmed.

For students from other Universities

- i** Students from other Universities should submit an undertaking at the time of admission regarding compliance of eligibility criteria as laid down by the University of Mumbai. The prescribed undertaking form is given in Annexure-1 hereunder. (The application for provisional statement of eligibility along with the supporting documents are to be submitted in the college office after the admission is confirmed and as per the notice which will be displayed separately on the college website).

Grant of admission

- i** The admission will be granted based on marks obtained in Bachelor of Commerce of University of Mumbai (Three years integrated programme) of the degree of B.Com. (Old programme) of University of Mumbai or Bachelor of Commerce (Accounting and Finance) or B.Com. (Banking and Insurance) or B.M.S. examination in SEM V and SEM VI (Excluding Applied Component).
- Students who have passed Semester VI but not yet got their Semester VI marksheet can also apply, however, their admission will be provisional.
- Students are required to fill the CGPA of Previous semesters i.e. Semester I, II, III & IV in the admission form too.
- Admissions would be granted on the basis of merit and abiding the set norms by University of Mumbai / State Government as may be applicable to the institution with autonomous status.
- The admission will be confirmed only after the verification of documents by the college authority and payment of fee by the student.
